### CERTIFICATE OF INSURANCE REQUIREMENTS FOR TEAM CART USE AND RENTALS

#### Coverages and Limited Required:

Team/Renter, at its sole cost and expense, shall obtain the following minimum amounts of insurance coverage:

**Commercial General Liability Insurance:** This insurance shall provide a minimum Combined Single Limit of \$1,000,000 each occurrence with General Aggregate no less than \$2,000,000. It must add the entities shown below as Additional Insureds. This insurance must be primary and noncontributory as respects any other insurance available to the additional insureds and waiver of subrogation must apply. Must note coverage applies for the operation of mobile equipment "pit vehicles" such as golf carts during the 2017 Toyota Grand Prix of Long Beach.

**Commercial Inland Marine Insurance:** This insurance shall provide a Replacement Cost Limit of a minimum of \$15,000 per cart rented.
