AGREEMENT

I am the Entrant identified above and hereby agree to purchase the Package in accordance with the following terms and conditions:

1. **PACKAGE.** The VIP Package Fee is non-refundable. Entrant will not be entitled to a refund if any portion of the VIP Package is not used by Entrant. The VIP Credential or any portion of the VIP Credential may not be resold and/or used for promotional purposes (i.e. sweepstakes, contest, giveaways, etc.).
2. **RECIPIENTS OF THE VIP CREDENTIALS.** Entrant must submit the name(s) of the person(s) in which they intend to receive a VIP Credential ("Recipient") no later than 10 business days prior to the Event in which the Recipient intends to use the VIP Credential.
 - A. Entrant acknowledges and understands the proposed Recipient must fill out and submit a Membership/License and Annual Credential Application to IMSA, acceptance of which is subject to IMSA's approval. If such proposed Recipient is not accepted by IMSA it will not count towards Entrant's Package.
 - B. Entrant represents and warrants that each Recipient is a guest of Entrant and will not serve as a team member, including without limitation, in any of the following categories: pit crew (over-the-wall pit crew, crew chief, pit crew support) a team member responsible for tires, fuel or pit operations, spotters, or race day support (crew, engine tuners, shock specialists, chassis specialists, or tire specialist, etc.) nor will they serve as a vendor providing service to Entrant, Entrant's team or any other team. Participant Accident insurance will not be available to the Recipients.
 - C. Entrant agrees to inform each Recipient of the IMSA's Code of Conduct set forth in the IMSA Rules. Entrant acknowledges and agrees that Entrant is responsible for the actions of each Recipient including without limitation their compliance with this agreement and the IMSA Rules and may be subject to penalties as a result.
 - D. A Recipient's Membership/License and/or Annual Credential cannot be transferred. If A Recipient's Membership/License and/or Annual Credential is suspended and/or revoked in accordance with the IMSA Rules, Entrant shall not be entitled to an additional VIP Credential nor a refund.
