1. DEFINITIONS. In addition to the terms otherwise defined, the following definitions apply to this Agreement: **“Invitees”** mean Corporate Member’s employees, agents and representatives; **“Raceway”** means the entity promoting and hosting the Event; **“Regulations”** means IMSA and the Raceways’ standard rules, regulations, policies, procedures, including without limitation the IMSA Rules which may change from time to time; **“Event”** means the sanctioned activity for the approved Series during the Season.

2. CREDENTIALS & PARKING PASSES.

A. Invitees. The credentials and parking passes shall only be used by qualified Invitees that are working or assisting Corporate Member in providing the Services at an Event. All credential holders **MUST** be eighteen (18) years of age or older and sign a Release and Waiver of Liability and Indemnity Agreement prior to obtaining a credential.

B. Use. Credentials and parking passes are non-transferable (except to qualified Invitees) and may not be used for consumer applications. Corporate Member and its credential holders are subject to the Regulations. Corporate Member shall be responsible for its Invitees’ compliance with the Regulations.

C. Credentials. Corporate Member’s Invitees that will receive an Annual Credential must be listed on Corporate Member’s Annual Credential Roster. Corporate Member’s Invitees that are to receive an SEC must be listed on Corporate Member’s SEC Roster for the applicable Event. The Annual Credential Roster and SEC Roster can be found on the Industry Support Portal. **Credential request must be submitted by 4pm EST the Friday before the Event week.**

C. Credential Access. Notwithstanding the foregoing, IMSA, in its sole discretion, may decide to limit or eliminate access to the paddock and/or pit lane area on an industry-wide basis for safety reasons. In the event IMSA decides to limit or eliminate access to the garage area, as set forth above, IMSA reserves the right to reduce or eliminate any credentials.

D. Parking Pass Limitations. Annual parking passes (where accepted) are subject to space limitations at each Event. Failure to provide a parking pass due to space limitations shall not be deemed a breach of this Agreement and Corporate Member shall not be entitled to any refund. Annual passes shall only be valid where accepted by the Raceway. Event specific parking passes are **NOT** included in the Industry Support Package.

3. TRADEMARKS. This Agreement does not grant Corporate Member or its Invitees any right or license to use any trademarks, service marks or copyrights of IMSA, including without limitation the IMSA logo, Series logos, title of any Event, either alone or with any other mark and any use by Corporate Member or its Invitees is strictly prohibited. Nothing herein grants “Official Sponsor”, “Proud Company”, or “Title Sponsor” status, or any other designation to Corporate Member with respect to IMSA, any of its Series or Events.

4. NO GUARANTEE. Customer specifically acknowledges that IMSA may also enter into separate agreements with other companies, including companies competitive with Corporate Member and nothing in this Agreement shall be construed as a promise or guarantees that any IMSA member will purchase products or services from Corporate Member. IMSA shall not be held liable for any indirect, consequential, special, incidental or punitive losses, damages or expenses (including, without limitation, lost profits and/or opportunity cost) even if advised of their possible existence.
